Candidates are assigned to churches upon acceptance. Village Missions also provides salary support. Approximately 83 of 189 churches served received full or partial salary support in the year.

Christianity Programs: Conferences - Village Missions subsidizes regional conferences to gather for mutual edification, encouragement and equipping.

Christianity Programs: Candidate School - Village Missions conducts orientation classes to screen and train prospective Village Missionaries.
