Christianity Programs: Provide spiritually qualified missionaries to rural churches. Village Missions recruits, screens, trains and hires prospective candidates for ministry. Candidates are assigned to churches upon acceptance. District Representatives come alongside to provide guidance to the church, and mentoring and supervision to the Village Missionary. Village Missions also provides salary support, as well as a group health plan and related benefits. Approximately 83 of 189 churches served received full or partial salary support in the year.

Christianity Programs: Conferences - Village Missions subsidizes regional conferences to gather for mutual edification, encouragement and equipping.

Christianity Programs: Candidate School - Village Missions conducts orientation classes to screen and train prospective Village Missionaries.
